7.1 Precautions for safe handling : Avoid contact with skin and eyes. Avoid inhalation of vapour, spray or mist. Appropriate engineering controls : Provide adequate ventilation. Where reasonably practicable, this should be achieved by the use of local exhaust ventilation and good general extraction. If these are not sufficient to maintain concentrations of particulates and solvent vapours below the OEL, suitable respiratory protection must be worn.

Individual protection measures

Hygiene measures : Wash hands, forearms and face thoroughly after handling chemical products, before eating, smoking and using the lavatory and at the end of the working period. Where possible wet sanding or chemical stripping methods should be used with surfaces of this type to avoid the creation of dust.
